All charges are exclusive of VAT at 20%

# <u>Livery</u>

Stabled livery includes bedding on straw or shavings, hay or haylage, hard feed and appropriate exercise (turnout, lunging, hand grazing/walking and possibly riding by arrangement), to ensure your stallion is kept in peak condition for collection.

# Semen Collection, Processing and Freezing

Collection for Chilled Semen(Usually invoiced to the mare owner)To include collection of semen, assessment and processing, centrifuging ifnecessary, extending with the relevant chilled semen extender andpackaging ready for postage or pickup by client.	£ 135.00

# **On Site Health Tests for Export Purposes**

Health tests are required to comply with import regulations and vary from country to country. We will advise in advance what tests may be required. All charges include the cost of sample collection by our vets, submission to APHA, postage and all APHA lab charges.

Note all charges are per insemination dose. One insemination dose comprises of a stated number of straws (e.g. 3-8 straws) dependent on semen quality. All storage charges will be invoiced annually in arrears. Your account must be up to date before any semen can be released.

#### WEST KINGTON STUD STALLION CENTRE (WKSSC) - GENERAL TERMS & CONDITIONS

- 1. The agreed daily charge includes full livery and exercising of a stallion to the owner's requirements.
- 2. Unless otherwise instructed, semen will be collected as often as a stallion's sperm reserves allow during a collection period. In practice, the most cost effective schedule is usually one every 48 hours, or 3-4 collections per week. All ejaculates with semen characteristics within acceptable limits will be processed and frozen. Sub-standard ejaculates will be discarded and a charge will be made for the cost of collection and evaluation only. After processing, the post-thaw motility, concentration and longevity of each ejaculate will be evaluated. No doses of frozen semen will be recommended for commercial use unless the semen meets the minimum standards set by WKSSC (30% post thaw motility). At the end of the collection period, a full report on semen characteristics of each ejaculate will be prepared.
- 3. Although every effort will be made to freeze each stallion's sperm to the highest standard, no guarantee can be given for either the number of usable doses produced or for the conception rate that the semen will achieve when inseminated.
- 4. Health tests will be carried out to meet the requirements set by the importing countries as selected/nominated in the "Export Markets" section on page one of this agreement. Every effort will be made to meet the known requirements at the time of collection, but no guarantee can be given that changes to the regulations may be made in the future which might render the semen ineligible for import to the country for which it was intended.
- 5. WKSSC reserves the right to request a deposit for stallions whose semen is intended for export to cover the cost of required health tests and the initial period at WKSSC. If it is decided that the stallion's semen is unsuitable for freezing, the owner will be advised accordingly.
- 6. 48 hours' notice is required of your stallion's arrival at and departure from WKSSC. Arrivals/Departures are only permitted between 09:00 and 17:00. Arrivals/Departures outside of these times may incur a surcharge.
- 7. All charges will be invoiced to the stallion owner (or agent, if applicable) and payment is due before departure of the stallion from WKSSC. Any deposit paid will be allocated to the final account and any unused portion of the deposit will be refunded. VAT will be charged at the prevailing rate.
- 8. Routine veterinary, farriery and worming carried out at WKSSC will be charged at a cost. Non-routine or emergency veterinary requirements will be referred to B&W Equine Vets Ltd who will charge the owner directly.
- 9. If the stallion is insured, the policy should cover at least death as a result of injury, illness, disease, theft or mysterious disappearance. Cover should include veterinary fees and liability. The insurers must be informed of the stallion's stay and West Kington Stud Ltd must be noted on the policy whilst the stallion is resident at WKSSC.
- 10. Each stallion should arrive at the centre with the following items clearly marked: rugs as required, headcollar and rope.
- 11. Every care will be taken whilst the stallion is at WKSSC, but no responsibility can be accepted for accident, theft or disease.
- 12. Photos will be taken of your stallion on admission and discharge. From time to time we may take photos for teaching, social media and marketing. Please tick the box below if you would not like photos of your stallion to be used in this way.

# **Pre-Entry Health Test Requirements**

The following health tests must be taken exactly as stipulated below and within 30 days prior to the stallions arrival at West Kington Stud. All samples must be sent to the correct APHA laboratories. All lab reports must have been received and forwarded to West Kington Stud before the stallion can be accepted.

# Equine Viral Arteritis (EVA) - single sample to be taken - either:

- a. Non-vaccinated stallions: Serum Neutralisation Test on a sample of whole blood taken
- b. **Vaccinated or other EVA positive stallions** will require virus isolation carried out on a sample of fresh semen. A PCR test result is sufficient. Please discuss this with West Kington Stud before beginning sampling, as it will affect export requirements.

# **Equine Infectious Anaemia (EIA)**

Serum Neutralisation (Coggins) Test on a sample of whole blood.

# **Contagious Equine Metritis (CEM)**

Two sets of culture swabs taken exactly 7 days apart and from each of the following four sites:

- 1. Prepuce
- 2. Fossa including sinus
- 3. Urethra
- 4. Pre-ejaculatory fluid

In addition to microaerophillic culture, one set of swabs should be cultured aerobically to test for the presence of *Klebsiella pneumoniae* and *Pseudomonas aeruginosa*.

# NOTES ON SAMPLES

- All tests MUST be taken within 30 days of the stallions admission to WKS.
- If used for natural covering, tests must be taken at least 15 days after last covering a mare.
- The rcurrent APHA forms must always be used for submission.
- Please remember to use the **registered name** of the stallion on the samples and accompanying paperwork, together with the sample date.
- <u>Blood Samples</u>: One tube of whole blood for each test. Samples to be sent to APHA Weybridge, Woodham Lane, New Haw, Addlestone, Surrey KT15 3NB
- <u>Penile Swabs</u>: Swabs, in charcoal transport medium, sent to APHA Penrith, Merrythought, Calthwaite, Penrith, Cumbria CA11 9RR, to arrive within 48 hours of sampling.

**APHA require that swabs must be kept chilled (but not frozen) during transit.** To avoid postal delays, it is advisable to send samples by Special Delivery.

# Stallions will not be admitted to WKS unless ALL lab reports have been received with negative results.
